Conditions for Use of Open Government Data Platform

Open Government Data Platform provided by Digital Government Development Agency (Public Organization) (DGA), is broadly facilitated government organizations to publish their data on the website at https://data.go.th, for the purposes of transparently providing data search and access to the public as well as promoting their involvement and inspection on governmental activities and encouraging them to further use the data to develop innovations and services, which would be benefitial to the country in certain aspects.

Government organization and the data user will be able to use data, which are contained on this website or thereunder, under the agreement to be bound by and comply with the following the conditions for Use of Open Government Data Platform.

Definitions

- "Conditions of Use" means the conditions for Use of Open Government Data Platform
- "DGA" means Digital Government Development Agency (Public Organization)
- "Data" means information are presented as facts or others as the same meaning. Whether such presentation could be known or assumed by its conditions or conveying through any methods, and whether it would be in any forms of documents, files, reports, books, charts, maps, pictures, photos, films, videos or voice records, information stored in or processed by a computer, or other methods which are used to present thereof.
- "Government Open Data" means open data in any digital forms whereof government organizations are able to disclose to the public, where are transparently reachable for the public without any expenses and beneficially processing or developing various services and innovations.
- "Organization" means state agencies own or possess copyrights, exclusive rights or any rights in relation to the Data, which are published on or throughout Open Government Data Platform where allow the Data User access to use the Data under the terms and conditions of permission.
- "Data User" means individuals, including body of persons, juristic persons, agencies and organizations access the Data, which are published on or throughout Open Government Data Platform, and use the Data under the terms and conditions of permission.
- "Service Provider" means personnel, staffs or administers of Open Government Data Platform.

"Open Government Data Platform" means management system which facilitates the Service to the Data User and supports the Organization's activities for the purposes of publishing and beneficially utilizing Open Government Data Platform.

"Service" means any acts that are the results of Open Government Data Platform provided by DGA to the Organization under the domain name (data.go.th).

"System" means information technology management of Open Government Data Platform under the domain name (data.go.th).

"Request" means any requests to the use of Service or alteration of the scope of Service, or any demands received from the Data User, which are related to any inconveniences of the use of Service or consultations about Open Government Data Platform.

"Complaint" means statements, which might be submitted when the quality of Service was unsatisfied or unacceptable under the terms and conditions of Service, are informed via channels of customer contact center where the Service Provider has determined.

"Use of Data" means the processing of Data, either in a whole or in a part, under both of lawful purposes, abided by the Data User and the agreement of the terms and conditions of permission.

"Administrator" means personnel of the Organization, who have registered to be a member of Open Government Data Platform for the purpose of administrating a system of their subordinated Organization, and needed to be duly authorized by management person of organization under the purpose thereof.

"User" means any individuals, including body of persons, juristic persons, agencies and organizations, or whoever use the Service and to be bound by and comply with the Conditions of Use.

Conditions of Administrator Registration

For the purposes of the efficient Service of Open Government Data Platform, the Organization shall perform as follows:

- 1. The Organization shall register as a member of Open Government Data Platform for the purpose of administrating the subordinated Organization's account. Administrator is duly authorized by management person of organization under the purpose thereof.
- 2. The Organization shall strictly comply with regulations related to Government Open Data regulations and relevant laws, including the terms & conditions for DGA Open

- Government License and this Conditions of Use, and not to cause any damage to the Service Provider.
- 3. The Organization shall log in to Open Government Data Platform by using an account issued by the Service Provider only.
- 4. The Organization has a responsibility for inspecting and certifying the accuracy of Government Open Data, which are sending or linking through Open Government Data Platform.
- 5. In the event that such Administrator status is changed or no longer to be personnel subordinated under the Organization or there is the Request from the Organization informing that such account is intentionally no longer used, the Service Provider shall suddenly terminate or suspend such account as the case may deem appropriate.
- 6. Data or any acts by the Organization , which are provided or executed throughout Open Government Data Platform, shall not be any prohibited conditions or contrary to laws or good morals.
- 7. The Organization has thoroughly read and hereby acknowledge this Conditions of Use and has affixed the signature in the Request form in recognition whereof.
- 8. In the event that the Organization detects any uncommon situations on or throughout Open Government Data Platform, such uncommon situation must be immediately reported to the Service Provider for the purposes of preventing and mitigating any incurred damage, which may impact to the Organization.
- 9. The Service Provider will safeguard personal data, which either belong to the Organization or the Data Provider in accordance with the applicable laws. The Service Provider will not disclose such personal data to third parties, unless such disclosure is necessary for operating of public tasks or exercising official authority designated to the Service Provider, or there is necessity to disclose such personal data according to the applicable laws, rules and regulations, orders from competent authorities or the court.
- 10. The Service Provider shall not provide neither warranty nor liability to any damage, which will be incurred by the Organization and might cause any impacts to Open Government Data Platform, arising from copyright infringements or violations of other rights that belong to the individuals, the organizations or other juristic persons, which the Service Provider does not have the legitimate power to authorize thereof.
- 11. For the purpose of using the Service, when the Service Provider has issued the account name and password to the Organization, at that time, the right of Data disclosure on Open Government Data Platform is executed under the Organization's right.

- 12. The Service Provider, at the Service Provider's discretion, reserves the right to suspend, either all or some, accounts belonged to the Organization , when the Service Provider found that the use of Service causes any impacts to overall scope of Open Government Data Platform, or the Organization or the Data User violates the relevant laws or the terms and conditions for DGA Open Government License and this Conditions of Use.
- 13. The organization hereby agrees and consents to provide the account name and password, which may be accessed or obtained any personal data, the organization's data and other data owned by the organization , for the purposes of investigation, consultation or issue handling on the use of Service. Such processing of the Data shall not deem to be illegal access or violation to any rights of the Organization . After the completion of abovementioned purposes, such password must be immediately changed for the security purpose.
- 14. The Service Provider reserves the exclusive rights, at all the time, to change, rectify or delete, either entirely or partially, this Conditions of Use as it deems appropriate, and the Organization hereby implicitly acknowledges and accepts such modification of the Conditions of Use upon the use of Service.
- 15. The Service Provider reserves the exclusive rights, at all the time, to modify, rearrange conditions, determine the limitation, suspend the Service, terminate or cancel either the scopes of Service or the certain Service, at the Service Provider's discretion, without prior notice, and the Service Provider shall not be responsible for any damage which may arise therefrom.

Conditions for the Use of Dataset

The User can access to use Data which are provided on or throughout this website under the agreement to be bound by and comply with the terms and conditions of DGA Open Government License.

Conditions for API Request (Application Programming Interface)

- 1. The User for API is the Data User, who asks for the Request, shall register to be a member of Open Government Data Platform under the API service in order to receive API key.
- 2. The User for API, who asks for the Request, can utilize the service by requesting to the website as data.go.th that uses the web service technology (API web) designated

- in RESTful style and sets the protocol to request API in REST style. The User for API shall write codes to correctly interface and proper to the determined connection.
- 3. The Service Provider will collect the User for API for the purposes of analyzing the Service's capacity and enhancing the System's capability, and API will allow to request the Service at the daily maximum capacity as 1000 times/the User for API.
- 4. The Service Provider, at the Service Provider's discretion, reserves the right to suspend, either all or some, accounts of the User for API, when the Service Provider found that the use of Service causes any impacts to overall scope of Open Government Data Platform, or the User for API violates the relevant laws or the terms and conditions for DGA Open Government License and this Conditions of Use of Open Government Data Platform.
